3. Appellant, Oregon Natural Desert Association, shall promptly notify this office of any outcome in the *Western Watersheds* case that may permit further proceedings in the consolidated administrative appeals.

4. The initial prehearing conferences now scheduled for Wednesday, May 7, 2008 are continued to **Wednesday, January 7, 2009 at 10:00 a.m.** (Salt Lake City, Utah time).
